Old Business:

Project P/Salamander technology discussion- Training for the Salamander system is scheduled for June 13th & 14th there will be a day & night session. Training for the Higgins system will follow the salamander training. The Command Boards are in and will be distributed to (3) boards per Town.

AD HOC nominating committee for 2007- The form were sent to the Association members on the mail list and put on the www.crfca.com website. Nominations for President, Vice President and Secretary/treasurer will be put forward and voted on at the June 28th annual meeting.

MDT update- Chief Willie Perez updated the group on the CAPTAIN system for the fire service. New Business:

Fire Captain Grant- there was no application filed this year due to the complexity of the application and the deadline time.

GETS Cards- The Government emergency telephone system (GETS) cards are available through the Capitol Region. There is no cost to get the cards and you may contact Cheryl Assis for the form.

Waterbury Firefighter Death- a moment of silence was observed for the death of Captain Keane from the Waterbury Fire Department.

The CREPC meeting will be held on the grounds of St. Joseph College in West Hartford inside the Medical reserve corp. special tent.

Shelter Drill- The shelter drill will be this weekend at the Elmwood community center.

The city of Hartford is getting a command post for the city. Enfield is also getting a command post and the Enfield command post was purchased with Town & CCROG matching funds. The Enfield Command post will service the northern part of the Capitol Region if requested. If there are any deficiencies with the existing command posts in the region ESF-4 or ESF-2 should generate a list of items that need correction and send the list to Cheryl or Bill.

Chief Richards discussed the “OPT OUT LEGISLATION” which requires Towns to submit a resolution to opt out of a mutual aid provision in the State. All Towns are automatically in the mutual aid program unless the Town CEO passes a resolution to OPT out. This also includes interstate mutual aid, and does not impact existing agreements between Towns.

Command Boards- a motion was made to distribute (3) command Boards to each Town. (Richards/Flynn) motion passed.

Salamander PDA's- a motion was made to distribute (2) PDA's to Task Force 51,52,53,54,55,56,57, Middletown & Tolland. Place (8) on CP-8 and allow a maximum of (4) PDA's from CP-8 to be available for training by departments in the capitol region. (Papa/Richards) motion passed.

John Shaw- MMRS informed all present that the “PUSH drill” which is a program to get medical information from 1st responders and family out on a form for medical supplies in a timely fashion at a POD, is still active and he hope to have more information at a future meeting.
